RELEASE AND WAIVER OF LIABILITY
THIS IS A VOLUNTARY RELEASE OF LIABILITY. IT IS ALSO A BINDING ASSUMPTION OF RISK AND INDEMNITY CONTRACT.

In consideration of my presence at the Humane Society for Greater Nashua ("HSFN") located at 24 Ferry Road in Nashua, New Hampshire, I, the undersigned, [REDACTED], on behalf of myself, my representatives, assigns, executors, and heirs (collectively "I"), hereby agree as follows:

This Release and Waiver applies at all times while I am on HSFN's premises, and whether or not I am interacting with a shelter animal.

Release of Liability and Hold Harmless.

I understand N.H. law holds the shelter animal's owner or keeper liable for damage caused by a dog, (N.H. RSA 466:19) however I hereby knowingly and voluntarily waive that liability, foregoing those laws and remedies.

I hereby fully and forever release, waive and discharge the Humane Society for Greater Nashua, its owners, Board of Directors, employees, volunteers, representatives and assigns (collectively the "Releasees") from any and all claims, demands, actions, or causes of action of any kind, which I may or might have against the Releasees, arising from/or by reason of, any and all known and unknown, foreseen or unforeseen, bodily injuries (such as jumping up, biting, scratching, etc) damage to property, and any consequences therefrom, which I may sustain due to my presence at HSFN, due to my interaction with a shelter animal or due to the Releasees' negligence.

I shall not bring any demand, claim, legal action against and/or sue the Releasees' for any economic or noneconomic losses due to bodily injury, death, or property damage as a result of the Releasees' negligence or my presence at HSFN.

I hereby agree to indemnify and hold harmless the Releasees' from and against any and all claims, liabilities, loss, damages, demands, actions, causes of action, including attorney's fees, costs and expenses of any kind, which may be made against them which arise out of my presence at HSFN.

Assumption of Risk.

I fully realize the risks and dangers of my presence around, or handling of, animals, and that these risks and dangers may be heightened with shelter animals. I fully assume these increased risks associated with HSFN's shelter animals. These risks and dangers include, but are not limited to:

(a) the propensity of a shelter animal to behave in ways that may result in injury, harm, or death to persons on or around them; (b) the unpredictability of a shelter animal's reaction to such things as sounds, sudden movements, and unfamiliar objects, persons, or other animals; and (c) potential of another person to act in a negligent manner that may contribute to injury to me or others.

I understand HSFN accepts shelter animals from numerous sources, including but not limited to: stray or abandoned animals, animals with behavioral issues, animals surrendered due to relocation, divorce, allergies, cruelty seizures and more.
